**CONSENT JUDGMENT AND  
PERMANENT INJUNCTION**

Civil Case No. 2:07-cv-559

As part of the settlement of this case, Plaintiff Easton Technical Products, Inc. and Defendants Dorge O Huang and Firenock, LLC ("Defendants") have consented to the entry of a permanent injunction against Defendants of the same scope as the Temporary Restraining Order previously entered by the Court on October 31, 2007 (Dkt. No. 28). Defendants have voluntarily dismissed with prejudice their third-party claims against Third-Party Defendant Robert W. Simonton.

Accordingly, based upon this Court's Findings of Fact and Conclusions of Law (Docket No. 33), and based upon the stipulation and joint motion of the parties, the Court hereby enters the following PERMANENT INJUNCTION:

IT IS HEREBY ORDERED that Defendants Firenock, LLC and Dorge O. Huang (collectively "Defendants"), including all officers, directors, principals, agents, servants, employees, successors and assigns, and all others aiding, abetting, or acting in concert or active participation therewith, are hereby permanently enjoined from infringing, directly or indirectly, United States Patent No. 6,390,642 ("the '642 patent), and specifically from making, using, selling, offering to sell, or importing the following products: Firenock v1.2, Firenock v1.5, Firenock v2.0s, Firenock v2.0a, Lightning Nock v2.0s, Lightning Nock v2.0c, Lightning Nock v2.01s, Actuator Magnet Pack (FNLN90), Actuator Bracket for Whisker Biscuit Arrow Rest (FNLN91), Actuator Bracket for Trophy Taker Arrow Rest (FNLN92), Extreme Shock Battery End Cap Pack (FNLN93), Bow-Fishing Fiberglass Arrow Adaptor (FNLN94), Actuator Magnet for Bow Fishing (FNLN95), Universal Refresh Pack (FNLN80), Matched Weight Practice Nock (FNLN81), Nock Proof Pack (FNLN82), and any other product that is a part of any of the foregoing products that constitutes the component that enables a lighted arrow nock system to be activated using a magnetic field, regardless of whatever "version" or name Defendants may use to label such products (collectively the "Infringing Products").


Defendants, including all officers, directors, principals, agents, servants, employees, successors and assigns, and all others aiding, abetting, or acting in concert or active participation therewith, are further ORDERED to immediately and permanently cease any attempts to sell any of the Infringing Products through advertising, marketing or promotion, including Internet

advertising and sales of promotional products that depict, promote, or otherwise mention any of the Infringing Products, and to immediately contact their distributors and/or dealers and instruct the same to stop all sales of the Infringing Products and to return all Infringing Products to Defendants.

All remaining claims, counterclaims, and prayers for relief in this action are dismissed on the merits, with the parties to pay their own costs and attorneys' fees.

IT IS SO ORDERED.
